

Guilty Pleasures Summer Fete Beautiful Baby & Toddler Competition Terms and Conditions

The competition will run between 12.00 - 3.00pm on Saturday 14th June 2014

1. This competition is open to the babies/toddlers of parents visiting to the Guilty Pleasures Summer Fete at Collingwood Centre, Collingwood Dr, Birmingham B43 7NF.
2. All information detailing how to enter this competition forms part of these terms and conditions. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules. The decision of the judges is final and no correspondence will be entered into. Entry will be taken to mean acceptance of these terms and conditions.
3. Parents should take their babies/toddlers to the Altered Images Photography stand between 12.00-3.00pm to be photographed. There will be an entry fee of £1 per baby/toddler which will be donated to the charity SPLATS. Parents will provide their name, address, telephone number & email address & the name of their child as confirmation of their entry.
4. Altered Images photographer will spend up to five minutes taking photos of each child. Altered Images photographer will select which he considers to be the best photograph to be entered into the competition.
5. There will be two categories of entry:
 - a) Babies aged from 3 months to less than 12 months;
 - b) Toddlers aged above 12 months but less than 3 years
6. Copyright in all photographs taken for this competition remains with Altered Images. In consideration of Altered Images providing the competition and prizes, each entrant grants a worldwide, irrevocable, perpetual licence to Altered Images to feature any or all of the images on their websites and/or in any promotional material subject to the following conditions:
 - that the photographs will not be used for commercial gain and will only be used to promote the photographer's business
 - that the names of the parents or their children will not be associated with the photographs
7. Only one photograph per child will be entered to be judged.
8. The winning entry in each category will be that that is judged to be the most visually appealing. The winners & runners up will be announced at 3.00pm on the day of the competition & will also notified within seven days.
9. The winner of each category will receive an 10" x 8" unframed print of their child's image plus a free individual or family photoshoot in their own home.
10. The runner up of each category will receive an 8" x 6" unframed print of their child's image.
11. The winner's & runners up's names may be disclosed to anyone who writes within one month after closing date, and enclosing a stamped addressed envelope, to Summer Fete Beautiful Baby & Toddler Competition, Altered Images, 28 Beacon Road, Sutton Coldfield, West Midlands, B73 5ST
12. All prizes are non transferable and there are no cash alternatives.
13.
